- we use building materials that have the appropriate approvals: the Polish quality mark "B" or European Union "CE";
- we will use equipment (cabinets, switches) adapted to the application of the LOTO system;
- we will provide technical supervision on site (minimum site manager) as required by the Building Law;
- we will carry out all work, especially work at height, while maintaining the applicable B.H.P. regulations;
- we will carry out all work in accordance with the art of construction on the basis of the "Technical conditions for the execution and acceptance of construction and installation work";
- use construction tools and equipment that are appropriate to the work to be carried out;
- we will use safety and protective devices;
- we will take measures to protect workers and members of the public;
- we will successively remove, during the course of the work, all elements which may endanger the safety of the persons carrying out the work and members of the public;
- in terms of final acceptance, we will check and confirm with a signature on the acceptance protocol the compliance of the works with the technical documentation and any changes and deviations, confirmed by appropriate entries in the Construction Diary, as well as compliance with specific regulations, relevant standards and technical knowledge, the quality of the completed works, leakage tests on all installations.

I confirm that:

- all equipment, objects, construction and other materials necessary for the execution of the contract are on our side;
- we will leave the aforementioned items in the location and premises indicated by the Contracting authority,
- we undertake to carry out the construction work in a "clean" manner
- we shall leave the premises after installation of the subject of the contract in a condition no worse than the existing one, including cleaning up all waste, debris, rubbish etc. at our own expense and risk.

We enclose with our offer a preliminary schedule for the execution of the subject matter of the contract and the documents resulting from Chapter IX of the request for quotation.

I (we) declare that I (we) meet the conditions of participation in the procedure, i.e.:

- a) The tenderer is authorised to carry out activities or actions relating to

- corresponding to the subject of the contract.
- b) The tenderer shall have experience in the execution of contracts with similar parameters and requirements as the subject of the contract and within the last 5 years before the deadline for submission of tenders (and if the period of operation is shorter, within this period) has executed at least 3 construction works (each under a separate contract), consisting in the installation of mechanical ventilation and shall present for inspection documents confirming the execution of similar contracts: references or a report, or any other document confirming the correct execution of supplies.
- c) The tenderer has the technical facilities necessary for the proper execution of the contract,
- d) The tenderer shall have at its disposal persons with qualifications and experience appropriate to the functions to be entrusted in the performance of this contract, including at least the following personnel:
- Construction manager - has a minimum of 5 years of professional experience, has a construction licence to manage construction works in the specialisation of sanitary installations without limitations (or an equivalent construction licence which was issued on the basis of previously binding regulations).
- e) The tenderer is in an economic and financial position to ensure the proper execution of the contract, in particular is not in a state of bankruptcy, restructuring or liquidation, including the submission of a certificate from the US and ZUS (or equivalent institutions from the country of the tenderer), of not being in arrears with public law liabilities (not older than 2 months from the date of submission of the tender).

At the same time, we declare that:

- a) The bidder has read the tender documentation and accepts the terms and conditions,
- b) The bidder has obtained the information necessary to properly prepare the bid,
- c) the subject matter of the offer fully complies with the description of the subject matter of the contract and with the other terms and conditions of the Request for proposals,
- d) the price entered on the offer form covers the remuneration for **all obligations** future Contractor, necessary for the execution of the subject matter of the contract,
- e) The Tenderer has no capital or personal relationship with the Contracting Authority. A capital or personal relationship shall mean a mutual relationship between the Contracting Authority or persons authorised to incur liabilities on behalf of the Contracting Authority, or persons performing activities on behalf of the Contracting Authority related to the preparation and execution of the contractor selection procedure and the Bidder, consisting in particular of:
- participating in a company as a partner in a civil partnership or partnership,

- owning at least 10% of the shares, unless a lower threshold is required by law or specified in other documents relating to the project,
 - acting as a member of a supervisory or management body, proxy or attorney,
 - be married, or have a consanguinity or relationship in a direct line, or a relationship of kinship or affinity in the collateral line up to the second degree, or be related by adoption, custody or guardianship, or be in cohabitation, his legal deputy or the members of the management or supervisory bodies of the economic operators competing for the award of the contract,
 - having such a legal or factual relationship that there is reasonable doubt as to their impartiality or independence in relation to the procurement procedure.
- f) the circumstances indicated in the following do not apply to the Bidder:
- Article 5k of Council Regulation (EU) No 833/2014 of 31 July 2014 concerning restrictive measures in view of Russian actions destabilising the situation in Ukraine (Official Journal of the EU No L 229 of 31.07.2014, p. 1), as amended by Council Regulation (EU) 2022/576 amending Regulation (EU) No 833/2014 concerning restrictive measures in view of Russian actions destabilising the situation in Ukraine (Official Journal of the EU No L 111 of 08.04.2022, p. 1),
 - in Article 7(1) of the Law of 13 April 2022 on special solutions to prevent support for aggression against Ukraine and to protect national security, for the duration of these circumstances.
- g) The tenderer shall be deemed to be bound by the tender for a minimum period of **60 days**,
- h) The persons signing the Bid Form **are authorised to submit a bid on behalf of the Bidder.**
