- we shall keep the site of the work free from traffic obstructions, store materials and equipment in the places agreed with the Employer and in good order, and dispose of unnecessary objects, materials, waste and refuse in the places designated by the Employer, in a manner consistent with generally accepted regulations,
- we will comply with the Employer's health and safety rules and fire regulations,
- we will leave the premises after installation, assembly and commissioning in a condition no worse than stagnant.

- be married, or have a consanguinity or relationship in a direct line, or a relationship of kinship or affinity in the collateral line up to the second degree, or be related by adoption, custody or guardianship, or be in cohabitation, his legal deputy or the members of the management or supervisory bodies of the economic operators competing for the award of the contract,
- having such a legal or factual relationship that there is reasonable doubt as to their impartiality or independence in relation to the procurement procedure.

f) the circumstances indicated in the following do not apply to the Bidder:

- Article 5k of Council Regulation (EU) No 833/2014 of 31 July 2014 concerning restrictive measures in view of Russian actions destabilising the situation in Ukraine (Official Journal of the EU No L 229 of 31.07.2014, p. 1), as amended by Council Regulation (EU) 2022/576 amending Regulation (EU) No 833/2014 concerning restrictive measures in view of Russian actions destabilising the situation in Ukraine (Official Journal of the EU No L 111 of 08.04.2022, p. 1),
- in Article 7(1) of the Law of 13 April 2022 on special solutions to prevent support for aggression against Ukraine and to protect national security, for the duration of these circumstances.

g) The tenderer shall be deemed to be bound by the tender for a minimum period of **60 days**,

h) The persons signing the Bid Form **are authorised to submit a bid on behalf of the Bidder.**
